SUBSCRIPTION RULES

The rules, listed further on, are applied to the subscription to the Members-only Area supplied by R&D associated study (Oleggio - via S. Eusebio 20/h - 28047 Oleggio (NO) - Italy). This society manages The Italian Taste website(www.theitaliantaste.com).

Everyone who subscribes to this restricted area (mentioned further on as "Member" or "Members") must accept all these rules.

1. Terms and conditions of the Service.

You have to read and agree to Privacy Policy and Subscription Rules in order to subscribe to Members-only Area.

You have to pay an annual fee to access to the Members-only Area. R&D s.a. shall decide every year the amount of the fee.

R&D a.s. asks to every Member only the data necessary for the invoice. Then only the data necessary for the account management will be kept (username, password, email address and subscription date). Other data may derive from the mode of payment (PayPal or bank transfer). Every change of the email address must be emailed (info@theitaliantaste.com).
